## Agenda 1: Welcome address and initial briefing to IQAC members about the meeting.

Dr. Priya Rai, University Librarian, NLUD, welcomed to all members and briefed about the agenda of this meeting.

Agenda 2: Discussion about the Report received from NAAC w.r.t Major Reforms in Rankings and Accreditation of Higher Education Institutions.



**Dr. Anju Tyagi** started the meeting with explaining about the report of Dr. Radhakrishnan overarching committee and asked the IQAC members to give their views / suggestions about the report for further submission to the Office of Honourable Vice Chancellor NLUD.

The detailed deliberations were done by the IQAC members on the Dr. Radhakrishanan committee report's recommendations, implementation, new methodologies and formats etc.

IQAC Team members discussed in detail about the Report and about Transformative Reforms for Strengthening Assessment and Accreditation of Higher Education Institutions in India and gave their views on the report.

**Dr. Risham Garg** discussed about the need to have a standard format / policy mechanism for timely and regularly collecting the placements and progression of higher education related data from NLUD students.

**Dr. Anup Surendranath** discussed about the Appendix 1 section of the report and highlighted the crucial challenges about the proposed framework in the report from the standpoint of a legal discipline university, for addressing the parameters pertaining to Input, Process, Outcome and Impact. He also mentioned that there should be visibility and transparency in the implementation process and the measurement mechanism for this recommended framework should be clearly defined to the HEI's.

**Dr. Manjula Batra** highlighted that the levels of the institution defined in the report needs more clarity and elaboration, also the framework of ranking and accreditation should be tailored keeping in view the paramount to the law school.

**Dr. Dinesh** discussed the interdisciplinary approach in research and innovation as per recommendations in the criterion –IV.

**Dr. Abha Yadav** raised the concerned about the periodicity of accreditation for a law discipline university and highlighted the concern that being a law discipline university governed by BCI norms there should be a reconciliation of points between BCI norms, NEP 2020 points and the ranking and accreditation framework recommended in the report.
